Fred is a career member of the Senior Foreign Service and the recipient of numerous USG awards – including the Distinguished Honor Award, the Secretary's Career Achievement Award, and the State Department's Award for Heroism for selfless actions under fire. He was profiled in the book "The Secretary", the National Geographic special "Inside the State Department" and the Discovery Channel's "Secrets of Diplomatic Security".

After retiring from the U.S. Department of State, Fred was the Senior Manager of Global Security Operations for one of the largest companies in the world and is currently a Vice President at a private security company. He is also the Executive Director at a global security firm, a Director for the Institute of Senior Professionals at Northwest Florida State College, a Board Member at the Board of Executive Protection Professionals, a member of the American Foreign Service Association's Speakers Bureau, and served honorably in the U.S. Navy.
